#### 第一部份

#### Native English Teacher (NET) Scheme

#### I. Objectives

It aims to support and strengthen English language teaching and learning in the school by

- 1. providing an authentic environment for children to learn English;
- 2. developing children's interest in learning English, helping them build the confidence for near-native communication, cultivating a lasting interest in, and establishing the foundation for, life-long learning of the language;
- 3. developing innovative teaching and learning methods, materials, curricula and activities suited to the needs of school students and enhance their English proficiency.
- 4. enhancing collaborative lesson preparation.

#### II Content of the NET Services

- 1. The service provider shall provide a qualified Native English-speaking Teacher (NET) to the service buyer and the NET must meet the requirements as set out by the Education Bureau.
- 2. The service provider should keep a clear and complete record of activities and materials used in delivering the service and produce it for inspection by the school or the Education Bureau upon request.
- 3. The service provider should agree to allow the Principal, the Panel Head and representatives of the Education Bureau to perform observation or inspection on the delivery of the service, if so required and necessary.
- 4. The service provider shall provide the NET enough support in designing a school-based curriculum to include engaging activity-based learning.
- 5. The service provider shall make sure that the lessons are conducted on time and to the satisfaction of the service buyer.
- 6. The first serving month of each NET shall be a probationary period. The service provider should replace the NET within FOURTEEN working days during the probationary period and within ONE month thereafter upon the request of the services buyer, provided that the serving NET is unable to perform the duties satisfactorily or misconducts oneself.
- 7. The service provider shall be responsible for arrangement and contributions of the Mandatory Provident Fund and employee's compensation insurance of the NET.
- 8. The service provider shall be able to offer a fixed monthly salary to the NET not less than 60 percent of the payment terms specified in the written quotation.

9. The service provider shall be able to provide a substitute teacher to the service buyer to guarantee the continuity of the programmes once the NET absent on account of sick leave, personal leave, emergency leave and any other leave.

#### III. Qualification requirement of the NET

- 1. The NET must:
  - i. be a native English-speaker; and
  - ii. be a university graduate; and
  - iii. hold internationally recognized English Language Teaching Qualifications including TESL/ TEFL and TEYL; and
  - iv. be with teaching experience, especially in teaching young learners; and
  - v. be with valid work permit or dependent visa or a Hong Kong Identity Card which allows the teacher(s) to work legally in Hong Kong
  - vi. have done Sexual Conviction Record Check (SCRC) and the School in-charge teacher(s) are allowed to have access to the checking results
  - vii. comply with the related policies and legislation regarding the measures to safeguard National security and National security Education

#### IV. Details of the NET services and duties

- 1. The NET service period shall consist of two options, which will be determined based on the qualifications, background, and work experience of the Native English Teacher provided by the agency. The service period options are as follows:
  - a. October 2, 2025, to May 31, 2026
  - b. September 1, 2025, to June 30, 2026
- 2. The service hours of the NET: 8:30a.m. to 4:30p.m.
- 3. Duties of the NET are as follows:
  - to undertake teaching duties and try out good teaching models/practices related to the learning, teaching and assessment of English;
  - to develop pupils' oral and reading skills (P.4-P.6);
  - to develop pupils' reading and speaking skills and arouse their interests to learn through holding English activities, e.g. Funland, phonics class, etc (P.1-P.3);
  - to be a consultant and in charge of the choral speaking groups, English Days;
  - to organize and conduct extra-curricular activities related to the English learning and teaching such as songs and dances, story-telling activities, games, school-based English camp, plays, enrichment courses, etc;

- to take initiative to talk to students during assembly, recesses, before and after school in order to promote a speaking environment and give opportunities for students to speak in English both inside and outside the classrooms;
- other duties within the working hours upon request.

#### V. Principle of Openness and Competitiveness

#### 《防止賄賂條例》:
